(Payment is required in full at registration)

- Cash (in person only)
- Credit card (VISA or MC only)
- Debit card (in person only)
- Personal cheque made out to 'University of Alberta'. No post dated cheques accepted; \$15 administrative fee levied on all NSF cheques

REGISTRATION, CANCELLATION, REFUND AND TRANSFER POLICIES

Registrations

- Separate registration forms required for each participant – one per child
- Parents/guardians must sign a waiver for each participant before camp begins
- Consent and waiver forms must be completed and returned to Augustana prior to camp beginning. No participation is possible without this being done.

– Please provide alternative choices. While we will try to accommodate your first choice request, this may not always be possible.

– If a camp is full, your child can be waitlisted for a class; we will contact you if a place becomes available.

Cancellations

– Cancellation requests must be submitted in writing and received by the Activity Registration Zone prior to the start of the camp. Effective June 15 2009

– Conditions:

- 25 percent cancellation fee levied on cancellations received five or more working days prior to the start of the camp
- 50 percent cancellation fee levied on cancellations received zero to four working days prior to the start of the camp
- In case of illness or injury:

– Prior to camp, a request to cancel must be accompanied by a medical certificate. Refund in full, less a \$15.00 administration fee.

– No refund if injury or illness occurs after camp starts

– No refund for no shows

Once the applicable cancellation fee has been levied, you have the choice of receiving a refund or credit: Refund – a \$15 administration fee will be assessed for all refunds

How you'll be refunded:

– If the original payment was by credit card, the refund will be credited to the card used for the original payment

– If the original payment was by cash or cheque, you will be refunded by cheque. This takes 3 – 6 weeks

– If the original payment was by debit card, the fee will be refunded to your debit card if you request the refund in person, or by cheque

Credit – Refund will be credited to your account and may be used towards any service provided by the Activity Registration Zone or Saville Sports Centre through the CLASS system.

Transfers

– A \$5 administration fee will apply to each transfer from one camp to another offered by the Faculty of Physical Education and Recreation

– If transferring to a camp of higher cost, you will be required to pay the \$5 administration fee and the difference in cost between the lower and higher-priced camps

– Transfers are permitted only within the same programming session and only if space is available
